OFFICIAL RULES: Chapel Hill Weekend Getaway Sweepstakes

Sweepstakes Period: "Chapel Hill Weekend Getaway" Sweepstakes ("Sweepstakes") begins at 12:01 AM Eastern Time ("ET") on June 1, 2010 and ends at 11:59 PM (ET) on August 13, 2010 ("Sweepstakes Entry Period").
